#### Membership

In Dick Allen's absence to the Far West, Nick Hardie reported that we have received 6 new applications for membership.

That puts the Waiting List at approximately 160! The Board unanimously approved written application by **Bob Knyrim** for Life Membership.

Recommendation of approval by the membership will be made at the April 7 general meeting.

#### Building & Grounds: Jim Rabjohn

A "bumper" for the Gator was purchased for \$130.00 (plus tax). Hopefully, this will prevent future encounters with trees out west.

He made some comments for the need for a York rake for roadways' maintenance. No action was taken on the question.

A request for possible availability of a good, used rake will be pursued at the general meeting.

#### Litigation, Insurance, etc.

Discussion wandered around what other club's were doing, who they were consulting for legal counsel, etc The possibility of shared legal counsel with other club's was raised as a possibility.

#### Club Calendar

The ongoing question of conflict s between clubhouse reservations, etc. and use of the Rifle Range was brought up but no conclusions were reached or decisions made. Suggestions for better definition of what a reservation covers were discussed. It was generally agreed that a "clubhouse reservation" applied to the clubhouse & pavilion ONLY although existing Ground Rules are not clear on the subject and may need to be updated.

Recently revised (primarily regarding permissible targets)

For example:

Rule 7, Rifle Range, Par.F. states "The Rifle Range is closed during all Invitational Shoots."

Rule 12 Use of the Clubhouse states "Any member wishing to reserve the Clubhouse or club for private use must make arrangements through the club's secretary. Members will be responsible for the actions of their guests, for cleanup of the clubhouse, ranges, and for anything missing or broken". (Editor's emphasis added).

There were varying opinions re interpretation and reasons/justification for the current Ground Rules. The practice (in place the last several years) of the Sporting Clays course being shut down Wednesday afternoon during the Summer Archery League shoots was also raised as unnecessary.

The meeting was adjourned at approx. 8:25 PM.
