The BOD was presented with a proposal for a shed for sale, for the archery group. The pricing, description and logistics of getting it delivered were discussed. The BOD deemed this may be a good solution for our needs. Some of the BOD Members will take a look at the shed before a final decision is made.

** UPDATE - as of the publishing of this NewsNotes, the shed was approved. As it was already budgeted for, a general member vote was not needed for this purchase. The archery group has cleared out their old shed; demolition of that shed is underway; the new shed will be brought over on/about August 20, and put in place.

Regarding the purchase of a new mower, that the club is in need of ... the BOD was presented with a couple of pricing quotes from different places, for different options/mowers, from members who had been researching this. The BOD will be looking at the pricing, and all considerations surrounding this need. When a decision is reached, the BOD will make a recommendation to the general members, who will vote on this.

Ranges Report/Safety: Frank Petricone

When you come to shoot, if possible, please try to plan ahead and have correct change, smaller bills, to pay. The Rifle League is still going strong. The Shady Range will be fixed up pretty; come out and use it!

Someone has come forward interested in taking over the sporting clays, for Joe Prince, who has asked to step down.

We will confirm this.

The BOD discussed the possibility of North Star getting a gate, near the road/entrance, to come in and out of club property. This would prevent people, who are not members, from coming on our property; preventing the potential for someone getting hurt; theft. This will be looked at more thoroughly; discussed with the general members.

Special BOD meeting Sept 7, 2017

The meeting was called to order by Pres. Pete McCann at 6:30 PM.

The primary purpose of this special meeting was to address a proposal to buy a new tractor and finishing mower to the general membership at the upcoming meeting immediately following.

Treasurer's Report: Harry Reiter

Harry provided a fine summary of the 10-year history of club Income & Expenses, concluding that the proposed purchases would not jeopardize the club's projected financial position over the next 3 years.

Aug-Sept 2017 NewsNotes

Refer to the details below, which were included in Harry's projections. He has taken into account long-range forecasts of target & other major items and the 10-year history of the club's finances. He also addressed a list of ideas mentioned by members for increased income, which he did not see as necessary to support the proposed expenditures. He concluded that the club could support the proposed purchases and continue "business as usual" at least for the next several years w/o jeopardizing the Reserve Fund, which is set aside for major unanticipated expenditures.

New Equipment proposal:

As noted in the Special Board of Directors notes of the meeting held earlier tonight, the following proposal was made to purchase new equipment needed for grounds maintenance:

- (1) **New Tractor:** KUBOTA 50 HP Model L4760 diesel w/ heated cab. (Slightly used, 40 hrs. w/ new warranty)

Cost: \$33,000.00 to be paid in 3 installments of \$11,000.00 each.

- (2) **Finishing Mower:** Kubota, Model ZD1211L diesel. 72" deck. Cost: \$16,000.00; 40 mos. @ \$400.00/mo.

Aug-Sept 2017 NewsNotes

The proposed plan calls for a trade of the old 4310 tractor & finishing mower for fork lift & snow plow for the new tractor. As noted above, the plan calls for no significant change in how North Star has been doing business for the foreseeable future and does not call for an assessment of the Reserve Fund.

The proposal was approved by voice vote of those present w/ no dissenting votes.

Target Inventory:

Allan Rice reported that we have 60 cases of mini-targets and no trap which can use them. He recommended purchase of a trap for this purpose for approx. \$3,050.00 plus accessories. This purchase might be used in lieu of other tentative trap purchases included in future budgets. The Board will consider this proposal.

MCCC, etc: Chris Wiest

Not much to report. Congressman Collins is working on a "SAGA" bill to "save the 2nd Amendment".


